

**TIMKEN HIGH SCHOOL ALUMNI ASSOCIATION SCHOLARSHIP APPLICATION FOR:**

- **CURRENT HIGH SCHOOL SENIORS WHO ARE DESCENDANTS (SON, DAUGHTER, GRANDCHILD) OF TIMKEN ALUMNI,**
- **POST-SECONDARY STUDENTS WHO ARE GRADUATES OF TIMKEN HIGH SCHOOL OR WHO ARE DESCENDANTS (SON, DAUGHTER, GRANDCHILD) OF TIMKEN ALUMNI.**

1. Statements on this form referring to Timken High School shall apply to Timken Vocational High School and Timken Senior High School.
2. The association may give one (1) or more grants to qualifying individuals each year. The number and amount of the grants given each year is subject to the approval of the Board. The Board reserves the right to not issue any grants if it feels the Association is not financially able.
3. **For current high school seniors,** the Association will pay for the grant or grants directly to the recipient's school upon receipt of proof of enrollment as a student in an accredited trade school, college or university.

**For post-secondary students,** the Association will pay for the grant or grants directly to the recipient for use to pay for school expenses.

4. The officers and trustees, or an appointed committee, will review the applications and make the decision as to which applicants will receive the grant.
5. The applicant must be a graduate of Timken High School or a descendant of a graduate of Timken High School.

**PLEASE NOTE: If you are applying as a descendant of a graduate of Timken High School, the Timken Alumnus from whom you are descended must be a PAID MEMBER IN GOOD STANDING of the Timken Alumni Association.**

7. The applicant, if chosen, must prove to be enrolled as a student in an accredited college/university, community college, or trade/technical school that results in either the granting of a degree or a certificate (a credential awarded by a postsecondary institution for completion of occupationally oriented courses typically lasting a year or less).
8. **THE APPLICATION MUST BE ACCOMPANIED BY AN OFFICIAL TRANSCRIPT OF GRADES FROM THE APPLICANT'S HIGH SCHOOL OR COLLEGE/UNIVERSITY.** Canton City Schools' graduates can request transcripts to be sent by calling the Student, Family & Community Support Office at (330) 438-2523.
9. All statements on the application must be true.
10. The Alumni Association must receive applications no later than MAY 1st of the year in which the grant is to be made.
11. Failure to comply with the application qualifications as listed above will be grounds for disqualification upon decision of the Association officers.
